Chief Executive Officer, Marty Wielgos, stated they basically held off any hiring late 4<sup>th</sup> quarter because it is really not a good time to bring new people on- there are a lot of people taking vacation and it is just really not a good time for the training process. Now, that they are into the 1<sup>st</sup> quarter in January, Jeff has a couple openings- a couple that will be in the Lab, an operator and maybe a laborer position available, so they are going to be posting those. One of the people—what is unique about the Sanitary District just to refresh the Board. When he was a Board member, the Mayor actually asked him to bring that to the table for a vote and the Board graciously did. The Sanitary District in Hammond is the only unique entity that allows its employees to make a choice to either live in Hammond or the Town of Munster. No other entity in the City of Hammond allows that. Everybody else, if you work for any department in the City of Hammond, you have to live in the City of Hammond. The Hammond Sanitary District has that unique opportunity. He just wanted to refresh everybody on that. He told Commissioner Hawkins if he knows any folks that are looking for work—they have one lady, and he asked Jeff to correct him if he is wrong, who he had met several years ago who has—He asked Jeff to explain what ability and knowledge she has and he will pick up from there.

Jeff Massey explained that she worked in the Scientology lab at Community Hospital for a number of years and then she is also a Registered Mortician. She has a strong Chemistry background which is something they are looking for in the Lab.

Marty added and she now resides in the Town of Munster. She was afraid that if Jeff hired her, she would have to move and they told her no, she does not have to move at all.

Commissioner Hawkins said that if they have postings, he would ask that those be sent to either him or Dustin Anderson with an explanation, but if they are sent to him, he will do that, so they can post them in Munster.

Jeff said he will do that.

Commissioner Hawkins stated that he noted in the board meeting minutes from the last meeting and he remembers they talked about the situation with fraud and a check and he is wondering if there is any update on that.

Rachel replied there is not. It takes a while. Their bank has to try and communicate with the bank that cashed it which in this case is Fifth Third. They said 9 times out of 10, the bank that cashed it won't send over information, so they have to take their time. They have to allot them time to respond, so she did say it was a lengthy process.

Marty added that when he was told that and said that he asks Rachel probably once a week about this check because the District is not only out \$5000, but technically \$10,000 because they had to issue another \$5000. He has had communications personally with Rachel and the bank and he told them that he wishes the process would be a little quicker for a couple reasons. One, the District is a pretty big customer of the bank. That is number one. Two, it was at no fault on the District's end that this activity took place. None at all. Somebody got a hold of it in the mail or at the place it was being delivered. They do not know. Number three, is that he wants more pressure put on Fifth Third by their bank. The District filed a police report and it just seems—he would think, and he does not want to say things negatively because they love their bank, but he would think the bank would have some kind of insurance that covers this type of thing.

Commissioner Rubio asked what was the date of the fraudulent check.

Marty responded that they can get her that information. He does not think they have that.

Commissioner Rubio said she thought she had seen something in the Bank Reconciliation document.

Rachel replied that the stolen check—

Commissioner Rubio asked if this is something that has been going on for a long time.

Rachel answered no.

Kaleigh added she thought it was September.

Rachel said it is always going to just hang out on the bank rec because they haven't received the money back yet. She looked up information and said, yes, it is from 09/15/2021.

Marty commented again that he wanted to say they love their bank—

Commissioner Rubio commented that they see this all the time at the bank. During Covid, she will say that they have seen so many lock boxes get broken into and checks stolen, so clients pay through a lock box service, those checks were stolen and the checks were washed so it was a legitimate check with a good signature and check number, but it was made payable to somebody else and maybe the dollar amount was changed. It is a process. They normally say 90 days and they are insured, so they will get their money back. The other thing is if they have not heard back, they can give provisional credit to refund back those funds.

Rachel replied they thought so too, but she said no.

Marty said he would be happy with a provisional credit unless they find something that is totally out of whack and they say they have to take the \$5000 back because it is this, this or that.

Commissioner Rubio stated that someone at her level or higher can push it and definitely make sure. She is going to look up the information so the District can get a provisional credit.

Marty answered that would be great. He thinks this is why Commissioner Hawkins, and he does not want to speak for him, but they have a lot of things to watch for and do so something like this will fall through the cracks because time has passed. It is \$5,000 and not \$100,000 so it falls off of the radar. He is not saying that it would, but he is one to address it immediately so that it does not happen. Like he said, he believes that First Midwest—Fifth Third should be held responsible right now because they are the ones who unfortunately got the bad check. It had to be a customer of theirs or something, but unfortunately that is where it stopped, so that is why they are pushing so hard because it has been to him a long time (September of last year) and—

Commissioner Rubio commented that she will definitely get it resolved before the next meeting.

Marty thanked her.

**President Dimopoulos called for New Business**

Marty stated that he thinks it would be an appropriate time to introduce the new Commissioner.

President Dimopoulos commented that Monica Rubio is their new Commissioner. Welcome. He said she can see how efficient they are here. He said they are so efficient here because of the great staff and personnel here that run the whole operation. Again, he welcomed her and asked if she had any questions.
