Whiting had not gotten billed, but they corrected that problem and they will be getting their bills here fairly quickly. They are trying to set up a meeting with Whiting to hammer out the final details of their agreement. As far as Highland and Griffith, they have received nothing. As of this new bill getting ready to go out which is their second bill, it will also include late charges and interest.

Attorney Allegretti added that actually the negotiating with Highland and Griffith has invoked the dispute resolution process that was contained in their letter of intent. That process includes a meeting that they are having Monday and then each party selects an arbitrator and then the matter continues to be resolved in that fashion. Hopefully it will not be as time consuming as the
